Sinus Forte is a unique combination of Eyebright herb, Golden Seal root and rhizome, Golden Rod herb, Echinacea root and Cayenne fruit formulated for sinus support.*

Mucous membranes in the nasal passages

Mucous membranes are located on the lining of body cavities including the respiratory tract. They are designed to protect delicate body tissues that have some exposure to the outside world.¹ Inside your nose is a series of structures called turbinates. When you breathe, the air is forced over the turbinates (their shape creates turbulence in the breathed air). Each turbinate is covered with a mucous membrane, containing a rich blood supply and having the following functions: (1) trapping dust and other particles, and (2) warming and humidifying the air.¹ The nasal passages act as an air conditioner and help ensure ongoing healthy resistance in these and the lower respiratory tissues.^{2,3}

Closely related to the nose are the sinuses. They are hollow chambers in some of the bones of the face that connect with the nasal cavity. The sinuses are also lined with mucous membranes and help to humidify the inhaled air. The sinuses have another important function: they cause a unique resonance in your voice as the sound waves bounce in and out.^{1*}

How Sinus Forte Keeps You Healthy

Maintains healthy and normal mucus secretion in nasal passages

Eyebright, Golden Seal and Golden Rod have been used traditionally to support and maintain healthy mucous secretion in the nasal passages.^{4,5} Golden Seal also improves the tone, vigor and function of these mucous membranes. Due to its pungent, hot and spicy nature, Cayenne is thought to assist the nasal passages by promoting healthy blood flow in the mucosal tissues. Cayenne became an important herb in the late 19th Century for the natural clinicians in the United States because of its ability to bring "vital heat" to the body.⁴ By maintaining healthy nasal passages these herbs also support free and clear breathing.*

Supports healthy response to occasional seasonal stresses

Eyebright, Golden Seal and Golden Rod have been used traditionally to support a healthy response in the nasal passages when challenged by occasional, seasonal stresses.^{4,5*}

The root of *Echinacea purpurea* was used by the Native Americans to enhance immune system function.⁶ A placebo-controlled trial found that *Echinacea purpurea* root assists the body's immune response by helping with normal phagocytosis.⁷ This is a process involving certain white blood cells that engulf and digest foreign particles or cells that might challenge the body. A practical effect is that top quality Echinacea root helps the immune response following stress or sudden changes in weather.

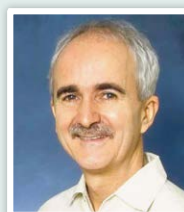

Research conducted by international groups strongly suggests that the alkylamides (pronounced al-kyl-a-mydes), present in high amounts in the roots of Echinacea:

- are very important for the immune system effects of Echinacea⁸⁻¹⁰
- are absorbed into the bloodstream^{11,12*}

Why use herbal products from an environmentally-responsible manufacturer?

Herbal products are made from living plants. It is extremely important that as consumers and manufacturers we do all we can to ensure their sustainability. Many species are threatened by destruction of their habitat and by unsustainable harvesting. One such example is the wild crafting (collecting from the wild) of *Hydrastis canadensis* (Golden Seal) in the United States.

In June 1997, Golden Seal was included in the Convention of International Trade in Endangered Species (CITES). This means that the international trade of Golden Seal is regulated and monitored to help ensure the plant's survival.¹³ However, CITES regulations do not monitor the trade of Golden Seal in the U.S., so it is vital that you ensure any Golden Seal product you choose is from a cultivated source. MediHerb has a strong policy on endangered and threatened medicinal plants, and only purchases cultivated sources of Golden Seal root and rhizome.*

What Makes Sinus Forte Unique

Sinus Forte is unique in the professional herbal products industry because:

- Top quality organically grown plants are used in the manufacture of the Echinacea and Golden Rod components of this tablet
- Only top quality *cultivated* plants are used in the manufacture of the Golden Seal component of this tablet

- MediHerb helped develop some of the chemical analyses used to regularly test the quantity of alkylamides in Echinacea raw materials
